The DFKDC Holiday Celebration is more than a seasonal party; it is our culminating year-end event that gives our participants (the beneficiaries of our free DFKDC clinics) the opportunity to "pay-compassion-forward". Participants engage in a variety of philanthropic activities at the Holiday Celebration including: wrapping presents for underprivileged children; decorating desserts for homeless shelters; making holiday cards for Veterans, and more. The DFKDC Holiday Celebration is a time for fun and philanthropy, and a reminder that their disabilities will not hold them back from reaching their potential.
